



NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS

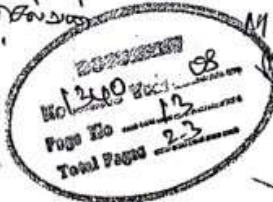

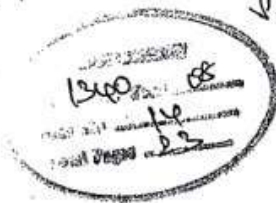

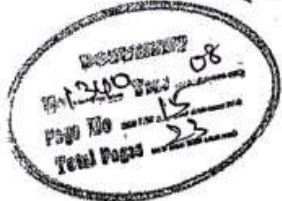

C) To acquire lands, buildings or other movable, immovable properties for the Trust with the funds of the Trust for the purpose and the objects of the Trust.

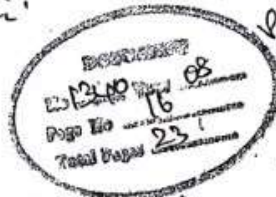

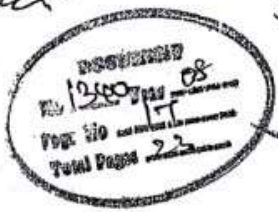

L) The bank account of the trust shall be opened in the Trust name and operated by the any two of the Managing Trustees as decided from time to time by passing resolution.

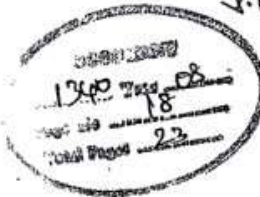
M) The trustees may meet together as and when they think fit and necessary to consider important matters concerned with the Trustees and its management.

P) In the event of dissolution or winding up of the Trust, the funds and property of the trust shall be transferred/ received to or from other charitable trusts of having similar object.

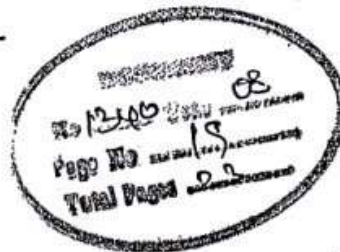

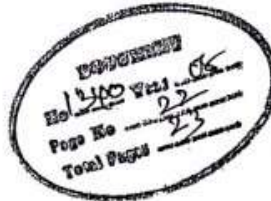
